

## TERMS & CONDITIONS OF THE CANDYLAND SCRATCH CARD 2025 PROMOTION

**Participation to this promotion is deemed acceptance of these terms and conditions.  
Participants who do not agree should not proceed with the promotion.**

1. **ORGANIZER:** Samsonite Europe NV, Westerring 17, B-9700 Oudenaarde (hereafter “Samsonite”), is organizing the promotion detailed in point 2 below and in these Terms & Conditions (hereafter, jointly or together referred to as “Promotion”).

### 2. PROMOTION

Prizes and value: 3x Create Cotton Candy Maker (49,95 eur)

Countries eligible: IE, FR, DE, ES, BE, NL, L, SE, DK, FIN, PL, HUN, CZ, SK, AT

3. **ELIGIBILITY:** The promotion is open to all residents of the countries mentioned for each of them in point 2, that have obtained the legal age (hereafter the “Participant”).

Directors, officers, management, employees, other staff, authorized agents, distributors and wholesale customers of the Organizers and their immediate family members or any of their affiliated companies or any other persons involved in the making of the Candyland Scratch card 2025 promotion are not eligible to enter or win.

Any participation not complying with these Terms & Conditions is invalid. The Organizers explicitly reserve the right to refuse or remove a Participant, at their sole discretion, in the event the Organizers determine a Participant does not comply with all rules and regulations as contained herein or as required by applicable law.

A scratch card is included with every order of a SoundBox Spinner 55, SoundBox Spinner 67 or SoundBox Spinner 77 in Pastel Green, Pastel Blue, Pastel Yellow or Pastel Pink on [www.americantourister.eu](http://www.americantourister.eu) (in participating markets) from February 7<sup>th</sup> until supplies last.

Customers need to scratch the prize box on the scratch card. If the customer scratches a SoundBox suitcase in Pastel Pink, they are the winner of 1 Cotton Candy Maker. Other scratch cards will show a sad smiley emoticon. To enter the promotion and validate their win, customers must follow the steps listed under point 6.
